TERMS AND CONDITIONS OF ACCOUNT

PAYMENT: Customer agrees to pay Pro Maintenance, Inc (dba Tampa Bay Mitsubishi Fuso) in full for all goods and services provided by Pro Maintenance, Inc. within ten (10) days of issuance of an invoice or statement for such goods and services. All invoices, statements and amounts due to Pro Maintenance are to be paid to 4306 E. Columbus Drive, Tampa, FL 33605.

LATE CHARGE: In event Customer fails to make payment in full at Pro Maintenance, Inc. within 10 days of issuance of an invoice or statement for goods and services, Customer agrees to pay a late charge of the lesser of 1.5% per month (18% per year), or the maximum interest allowed by law, on all outstanding balances until payment is received by Pro Maintenance, Inc.

STORAGE CHARGE: In the event Customer fails to pick up a vehicle within three days of completion of service work by Pro Maintenance, Inc., Customer agrees to pay a storage charge in the amount of Twenty (\$20.00) dollars per day.

WAIVER: Any failure of Pro Maintenance, Inc. to insist upon strict compliance with any of the terms and conditions hereof shall not be deemed a waiver of relinquishment of the right to subsequently insist upon strict compliance with the same or any other terms or condition, or constitute a waiver or relinquishment of any similar right or power hereunder at any subsequent time.

GOVERNING LAW/VENUE/JURISDICTION: This account shall be governed by and construed in accordance with the laws of the State of Florida. Customer consents and submits to the jurisdiction of the courts of the State of Florida and Hillsborough County, in any way to any goods or services provided by Pro Maintenance, Inc.

WAIVER OF JURY TRIAL: Customer waives any and all rights to a trial by jury on any matters relating in any way to this account or amounts owed to Pro Maintenance, or in relating in any way to any goods or services provided by Pro Maintenance, Inc.

AUTHORIZATION: Customer authorizes any bank, financial institution, creditor or any party identified in the Trade References section of the Application for Account, to release and disclose to Pro Maintenance any and all information relating to Customer's business and credit history.

ATTORNEY'S FEES: In the event Customer fails to pay Pro Maintenance in accordance with the terms of this account, and Pro Maintenance employs an attorney to collect amounts owed to Pro Maintenance, Customer agrees to pay to Pro Maintenance a reasonable sum for attorney fees incurred by Pro Maintenance, including all attorney's fees incurred on appeal or in any bankruptcy proceeding, plus all costs of collection and all other costs and expenses which may be incurred by Pro Maintenance, regardless of whether a lawsuit is filed against Customer.

REPRESENTATIONS AND ACKNOWLEDGMENT: Customer represents that the Customer information contained in the Application for Account is complete and accurate. Customer understands and acknowledges that Pro Maintenance is relying on this information in any approval of the Application for Account or extension of credit to Customer. Customer represents that he has read and understands all of the terms and conditions of account, and understands and acknowledges that, by signing below, Customer agrees to comply with and be bound by all such terms and conditions of account.
